Call to Order

Called to order in 5:17pm

Approval of the agenda

Business Arising

There was no business arising from the minutes

There was a round-table introduction of the members of the committee.

Presentations

Supt. Archie Thompson, RCMP

Supt. Thompson shared his background and work history. He clarified that he has responsibility over the Northeast Region, stretching from East Hants through to Cape Breton. He expressed an interest in meeting with the group, hearing the issues discussed, and getting to know the group better.

Judy Julian arrived at the meeting at 5:26pm

• Church Street Extension - Issues

The guest expressed issues with speeding, graffiti, "stunting," among other issues on the Church Street Ext.

Chair raised the question of what the Committee could be done to address the matters, as they expressed that the RCMP has a presence in the area. There is no pattern to the behaviour, which makes it challenging to address.

S./Sgt. Mooney addressed the concern, noting that they respond when they get calls, but they cannot post to that area as there are other issues to address in the community.

The Chair thanked the guest for the presentation.

RCMP noted that they do presentations to high schools and speak to the concerns raised by the presenter.

RCMP noted that the traffic unit is not the primary response unit to these matters but will assist if requested.

RCMP Update

S./Sgt. Mooney presented his report, as included in the package.

S./Sgt. Mooney indicated that calls are up, with an increase of nearly 100 calls for service more since the previous year at this time.

Question was raised regarding the number of impaired drivers indicated.

Sgt. MacBeath indicated that the report indicates reports of impaired driving, not those charged. It may also include cell phone offences but it may get registered as such because drivers on cell phones may show outward signs of impairment.

Chair raised the question of crimes against property in the Town

S./Sgt. Mooney notes that this involves mischief, such as property damage, general vandalism, etc. The numbers are consistent based on previous months, although minor thefts are up attributable to a single case; it is not indicative of a larger problem of issues.

Traffic offences was raised.

Sgt. MacBeath noted that those are largely speeding and complaints and that those occur on the highway. He noted that we will see that increase in the summer months.

S./Sgt. Mooney indicated that office and building renovations are moving ahead, and so far it has caused minimum disturbances to the staff. Discussed the progress of the project and work to date. Expected to be completed in the spring.

It was noted that cabs do run stop signs, and requested RCMP to review the issue at MacLellan, Arbor, and Delarosa. Consideration would be given to the speed reader board being placed in the area.

Roundtable

S./Sgt. Mooney shared that Annual Performance Planning was in the works, and issues could be provided to the RCMP to help shape that planning. Sgt. MacBeath shared matters that are considered as part of that plan review, including community engagement, etc.

Next Meeting

The next meeting is scheduled for June 4, 2020, at the County Council Chambers.

Notable Events

The month of May continued to provide Covid19 challenges but as the restrictions started to loosen, members returned to self generated traffic enforcement both in all areas of Antigonish County. These efforts are reflected in the traffic offence statistics. The increase can also be attributed to a rise in traffic related calls for service with many people still working from home or unable to go to work. Members also attended 19 Covid 19 related calls, 11 of those were mandated quarantine checks.

The Community Policing/School Resource officer,

Schools have been closed since the middle of March and Cst MacPherson has been assisting the Call Back Unit with COVID 19 related complaints. He will be returning to Antigonish Detachment July 1, and back to his regular duties, facilitating crime prevention initiatives, school programming and planning for the upcoming school year.

During the month of May, Cst Coleman transferred out to the Musical Ride. Her replacement has been identified and should be arriving soon. Two of the SCEU members are back in their regular positions having temporarily worked on Detachment to assist during Covid 19 adjusted shift schedule.
