CANADA 150 LEGACY PROJECT (For Decision)

REVIEW OF MUNICIPAL WATER & SEWER SYSTEMS (For Information)

The Committee is asked to provide further guidance on whether to use all property fronting the local improvement or only developed properties (residences or businesses).

DTIR COST SHARE AGREEMENT FOR SUBDIVISION STREETS (For Discussion)

DTIR has requested that the Municipality submit a prioritized list of street for consideration in the 2018-2019 fiscal year of the cost-share program for subdivision streets. Further to the discussion at the last meeting, a list of J-Class roads in attached for reference. Roads provided by councillors for consideration to date include West River Cross and Somers Road. All J-Class roads submitted for consideration will be considered by DTIR and an estimate will be returned to the Municipality for final consideration.

CALL TO ORDER

The meeting of the Asset Management Committee was called to order by the Chair, Councillor MacFarlane, at 5:30pm.

APPROVAL OF MINUTES

Moved by Councillor Chisholm and seconded by Councillor Dunbar that the September 5, 2017 Asset Management Committee minutes be approved. Motion carried.

BUSINESS ARISING FROM MINUTES

IN-CAMERA – ACQUISITION, SALE, LEASE AND SECURITY OF MUNICIPAL PROPERTY (WRIGHT'S RIVER AQUIFER)

These subject matters fall within Section 22(2) of the Municipal Government Act as matters that a committee may discuss in a closed session. It is recommended a motion be made to initiate an incamera session.

CONSIDERATION OF A WATERLINE EXTENSION IN NORTH GRANT

Discussion was held regarding the process of utilizing the Local Improvements By-law for a waterline extension to North Grant. Staff was requested to provide the Committee with a number of scenarios for the application of the Local Improvement By-law, for their consideration at the next Committee meeting.

REVIEW AND APPROVAL OF THE 2017/2018 CAPITAL INVESTMENT PLAN

Mrs. Duggan presented the Capital Investment Plan that she had prepared for submission to the Province. Some discussion was held regarding specific projects moving between years 2 through 5.

Moved by Councillor Chisholm and seconded by Councillor MacDonald that the Asset Management Committee recommends that Municipal Council approve the 2017/2018 Capital Investment Plan. Motion carried.

UPDATE ON THE COUNTY COURTHOUSE REPAIRS AND MAINTENANCE

Mrs. Schumacher provided the Committee with an update, and presented a staff report recommending a preferred service provider for a condition assessment on the building. Discussion followed regarding the requirements of the heritage designation, challenges and opportunities presented by the federal grants program, and work done to date on the building.

Moved by Councillor Deveau and seconded by Deputy Warden Stewart that the Asset Management Committee recommends that Municipal Council commission Heritage Standing Inc. to prepare a building condition assessment / conservation master plan for the Antigonish County Court House. Motion carried.

DTIR COST SHARE AGREEMENT FOR SUBDIVISION STREETS

Mr. Horne reviewed the letter from DTIR requesting a prioritized list of J-Class streets for consideration in the program. Discussion followed, and staff was requested to provide the Committee with a list of J-Class streets at the next Committee meeting.
