#### SEMI-ANNUAL DISCUSSION WITH LOCAL TIR REPRESENTATIVES

Basil Pitts, the new Area Manager for the local TIR office, will be attending with members of his team for a discussion and Q&A with members of the Committee.

#### FURTHER CONSIDERATION OF LOCAL IMPROVEMENTS (For Information)

There are two items on which staff are seeking guidance:

1) The method by which the Municipality determines support for an existing capital improvement project:

Projects on Council's capital priority list are subject to local improvement charges. Some have been in this list for many years; therefore we must determine the level of support by affected property owners. The Municipality has used both letters and petition to determine support (an example of each is attached). Each has advantages and disadvantages; after discussion staff was unable to think of another method.

Staff would like the Committee to discuss the best method for gauging community support for a local improvement.

2) Council approved the following local improvement priorities in January, 2017:

- 1. Somers Road Water
- 2. North Grant Water
- 3. Southside Harbour Sewer
- 4. Gaspereaux Lake Water
- 5. West River Sewer
- 6. Cameron Kinney Hill Water

Somers Road Water has been completed; we are awaiting final costs to provide the required bylaw amendment to Council.

During a previous iteration of the project, property owners received a letter to confirm their support. More recently, a petition has been drafted and provided to Councillor MacDonald to gauge community interest for a smaller North Grant water project.

Cost estimates have been produced for each of the remaining projects. Staff is prepared to gauge the support for affected property owners in Southside Harbour and Gaspereaux Lake for those respective projects.

#### CALL TO ORDER

The meeting of the Asset Management Committee was called to order by the Chair, Councillor MacFarlane, at 5:29pm.

#### **APPROVAL OF AGENDA**

The following item was added to the agenda:

• Introduction to Frankville Sewer Request

Moved by Councillor MacDonald and seconded by Councillor MacLellan that the agenda be approved. Motion carried.

#### **APPROVAL OF MINUTES**

Moved by Councillor Deveau and seconded by Warden McCarron that the October 17<sup>th</sup>, 2017 Asset Management Committee minutes be approved. Motion carried.

#### **BUSINESS ARISING FROM MINUTES**

A document of Municipally-owned property was circulated at Council's request.

#### NORTH GRANT WATERLINE

Mr. Horne presented information gathered since the last meeting regarding the options and scenarios for the proposal for a waterline to North Grant.

Councillor MacDonald requested that policy be amended to request approval from civic address rather than PID. Councillors discussed and came to a consensus that the policy would not be changed.

Councillor MacDonald will be in touch with each property owner to determine further action.

#### UPDATE ON ASSET MANAGEMENT PLANNING

Mr. Horne provided an update to municipal council on Asset Management Planning. On November 2<sup>nd</sup> the Municipality was notified that EXP Services has received updates in regards to changes with town infrastructure because of the university. Once these changes are incorporated into the model they will be able to run scenarios that Municipal Council will want to see.

Assessments are ongoing for the Sewer treatment plant in Lower South River, St. Andrews and Heatherton.

Staff has requested the tender documents be drafted for the Sylvan Valley Sewer Line Replacement and Trunk 4 Water Line looping so there are shovel ready projects for an Infrastructure Funding call.

Warden McCarron, Mr. Horne and Councillor MacFarlane have all attended Asset Management Workshops.

Provincial UNSM update, five municipalities were part of a pilot program to develop and test asset management tools designed to inventory all linear assets. We were unsuccessful to be selected as one of these municipalities. They focused on smaller municipalities.

Based on conversations with DMA, TIR and Infrastructure Canada, the next round of infrastructure funding should be announced for March or April 2018.

#### INTRODUCTION TO FRANKVILLE SEWER EXTENSION

Councillor Corbett would like a review to be done regarding the Frankville Sewer Extension. The initial proposed project was 4km and would service about 80 homes but Councillor Corbett would like an addition kilometer to be added to the sewer extension. This extra kilometer would service about 20 homes for a total of 100 homes. The extra kilometer would likely require 2 additional pump stations.

There are currently five projects that Council has identified as priorities. Mr. Horne suggested that this project could be considered among future infrastructure projects when Council looks at the next batch.

#### RE: Assessment Account #\_\_\_\_\_ - Extension of Municipal Water on Somers Road

Dear \_\_\_\_\_:

In response to a request by property owners, the Municipality has agreed to carry out a local improvement for the extension of a municipal water main on your street. The Municipality has received an estimate of probable cost for this capital project in the amount of \$695,000 plus HST. I wish to stress that this is an estimate.

In accordance with the provisions of the "*By-Law Respecting Charges for Local Improvements,*" where a local improvement is to be carried out by the Municipality, a tax is levied upon every owner of real property situated in whole or part within the identified area. A copy of the By-Law is available on our website at <u>www.antigonishcounty.ns.ca</u> under the tab entitled "Government."

For the local improvement requested on Somers Road, the property owners are required to contribute up to 20% of the project cost with the balance to be paid by the Municipality. Based on this division, the property owners' share would be approximately **\$4,765.00** per assessment account. If provincial and/or federal funding is secured for this project the residents share of the project costs will be lowered to a minimum of 12%.

This amount may be paid in equal annual installments over 10 years. In the event of default on any payment the whole balance will become due and payable. Please note that a charge imposed pursuant to this By-Law constitutes a first lien on the property in the same manner and with the same effect as rates and taxes under the Assessment Act. The charge for local improvements would appear as a line item on your annual tax bill.

In order for this work to proceed, the Municipality requires an affirmative response from the property owners of the impacted area. Please sign and return the enclosed letter indicating your support no later than April 7, 2017. If a letter is not returned, the Municipality will assume a negative response.

## If 34% or more of the residents are <u>not</u> in favor of this proposal, the work will not proceed. If work proceeds, all residents of the impacted area share the costs regardless of their support for the project.

I understand that a charge imposed pursuant to this By-Law constitutes a first lien on the property in the same manner and with the same effect as rates and taxes under the Assessment Act.

I understand that at least 2/3 majority support for the project among affected property owners is required to the Municipality to consider this local improvement.

I understand that even with 2/3 majority support for the project, Municipal Council will consider this request for local improvement in the context of its Asset Management Planning.
