#### a. Update on 2019/20 Capital Program

Mr. Myers provided an update on the North Grant waterline and the Church Street looping project. Mr. Horne spoke to construction timelines and plans to deal with weather if that becomes an issue. Updates were also provided regarding a proposed extension to the North Grant Waterline, and upgrades to the pumps at the lift stations in Mount Cameron.

### **STAFF REPORT**

#### RECOMMENDATION

That the Committee recommend that Municipal Council receive the proposed amendments to a By-law Respecting Local Improvements for First Reading at their February 10, 2020 meeting.

#### **SUMMARY**

Two capital improvements projects that have been completed in the County went through the Municipality's Local Improvement Process to impose capital charges as described in the Municipality's Local Improvements By-law. The paving of West River Cross Road and the extension of the municipal waterline on Beech Hill Road are proposed to be added to "Schedule A" of the By-law Respecting Local Improvements. A copy of the by-law can be found on the Municipality's website.

#### BACKGROUND

The Bylaw takes authority from Section 81 of the Municipal Government Act, which provides that, "... *council may make by-laws imposing, fixing and providing methods of enforcing payment of charges for..."* a variety of capital and other improvements. In short, it permits the Municipality to recoup capital costs from impacted property owners for capital improvements. To summarize from the definition used in the Bylaw, a local improvement is a new or extension to existing water, wastewater, and storm water (curb & gutter) systems, transportation facilities (roads, sidewalk, active transportation routes) or other anticipated capital requirement.

Through the Province's J-Class road cost sharing program, the Municipality was able to work with the Department of Transportation and Infrastructure Renewal to have a section of West River Cross Road repaved. This capital improvement is subject to local improvement charges and went through the required process to impose capital charges as described in the Municipality's Local Improvements Bylaw. A copy of the proposed amendments to "Schedule A" for this project is attached.

Further, when the Municipality extended the water line on Beech Hill Road to the municipal office, the area of extension included several properties beyond the municipal office who, though the process outlined in the Local Improvements Bylaw, agreed to the cost-sharing of a local improvements charge. A copy of the proposed amendment to "Schedule A" for this project is also attached.

#### Discussion

Section 81 of the Municipal Government Act, *By-law regarding the payment of charges*, allows for a municipality to adopt a by-law imposing, fixing and providing methods of enforcing payment of charges for a variety of capital improvements. Section 81(3) outlines the parameters of such a bylaw, many of which are included in the Municipality's by-law.

Section 4 of the Municipality's Bylaw states the following:

4. Charge Imposed Where a local improvement has been carried out by the Municipality of the County of Antigonish in an area identified in Schedule "A" as amended from time to time, a tax is hereby levied upon every owner of real property situated in whole or in part within the identified area except to the extent that any lot or the owner thereof is totally or partially exempt from tax by provisions in this By-Law or the provisions of Schedule "A".

Based on the Municipal Government Act and the By-law itself, the fixing and enforcement of capital improvement charges requires a by-law amendment. Specifically, amendments to Schedule A to include the West River Cross Paving and the Beech Hill Waterline Extension as improvements for which charges are fixed (Please see Schedule A attached).

Part VIII of the Municipal Government Act, By-Laws, outlines the procedure for consideration and approval of a municipal by-law. Amending a by-law requires the same process, which is:

- First reading of the proposed by-law or amendment (notice; a vote by Council to proceed to second reading is required);
- Published, public notice at least fourteen-days prior to second reading;
- Second reading of the proposed by-law or amendment (consideration of the amendment; a vote by Council to approve the by-law or amendment);
- Publication of the by-law, upon which it has the force of law.

The draft by-law amendments attached would follow this process and permit the fixing of capital improvement charges to the lots identified. It also provides for the fixing of charges for lots created in the future.

#### NEXT STEPS

First reading of these by-law amendments is anticipated for Monday, February 10<sup>th</sup>, 2020. Second Reading is tentatively expected for Monday, March 9<sup>th</sup>, 2020. In addition to published, public notice of the proposed amendments, a letter will be sent to property owners fronting West River Cross Road and the impacted property owners on Beech Hill Road informing them of the process and of the final amount of the capital improvement charge in advance of the second reading. If approved by Council, the amendment would have the force of law upon being advertised the week following the second reading.



## BY-LAW NUMBER #01-2020 AMENDING THE BY-LAW RESPECTING CHARGES FOR LOCAL IMPROVEMENTS

WHEREAS Section 81 of the *Municipal Government Act* provides that a Municipality may make bylaws imposing, fixing and providing methods of enforcing payment of charges for types of local improvements, and

NOW THEREFORE by the Council of the Municipality of the County of Antigonish enacts as follows:

1. That the By-law Respecting Charges for Local Improvements be further amended by adding the following to Schedule "A":

SCHEDULE "A"

2. West River Cross Paving – 2019.

a) The project will involve the paving West River Cross Road.

b) Properties with the following PID numbers shall be subject to the local improvement charge: 01211085; 10071637; 01211168; 01211093; 01211325; 01211077; 01210905; 01211432; 10103117; 01211101

c) The local improvement charge is a flat rate of \$2,200.00 per property.

d) Each property owner shall have the option of paying one upfront payment or equal annual installments to a maximum of five years.

e) Any property subsequently created fronting West River Cross in the area of the paving described herein is subject to the local improvement charge stated in 1(c) and the terms of payment stated in 1(d).

f) The cost of the project shall be subject to an interest rate of 0%.

## BY-LAW NUMBER #02-2020 AMENDING THE BY-LAW RESPECTING CHARGES FOR LOCAL IMPROVEMENTS

WHEREAS Section 81 of the *Municipal Government Act* provides that a Municipality may make bylaws imposing, fixing and providing methods of enforcing payment of charges for types of local improvements, and

NOW THEREFORE by the Council of the Municipality of the County of Antigonish enacts as follows:

1. That the By-law Respecting Charges for Local Improvements be further amended by adding the following to Schedule "A":

SCHEDULE "A"

- 2. Beech Hill Waterline Extension 2019.
  - a) The project will involve the extension of the municipal waterline on Beech Hill Road.
  - b) Properties with the following PID numbers shall be subject to the local improvement charge:

10058113; 10109015; 01249986

c) The local improvement charge is a flat rate of \$2,200.00 per property.

d) Each property owner shall have the option of paying one upfront payment or equal annual installments to a maximum of ten (10) years.

e) Any property subsequently created fronting Beech Hill in the area of the waterline extension described herein is subject to the local improvement charge stated in 1(c) and the terms of payment stated in 1(d).

f) The cost of the project shall be subject to an interest rate of 0%.

## **REQUEST FOR DIRECTION**

#### SUMMARY

This memo provides the committee with background concerning the need for a water tower in the area of Post-Road & Trunk 7 and a proposed path forward. Staff are seeking direction from the Committee and consensus to move forward as discussed. Staff are proposing that Municipal Council consider completing this project in FY 20/21.

#### BACKGROUND

The Municipality has been aware of low fire flows in the area of Post-Road, Trunk 7 and surrounding areas since the early 2000s. During this time plans to address these low flows were drafted but not carried out. This proposal to move forward with the construction of a water tower in service of this area comes directly from this earlier work. For a technical summary of the proposed tower and the affects of fire flows in this area, please review the attached April 23, 2019, memo from Strait Engineering to Public Works Director, Daryl Myers.

The proposed tower would be 117 feet tall with a 22.5-foot diameter and 340,000-gallon capacity. We are in the process of acquiring 1/2 acre on which to build the tower. This tower will service 800 existing residences and will provide enough capacity and fire flows for a 20-year residential and commercial build out.

#### CONSIDERATIONS

This project is designed to address the known issue of low fire flows in this area. This limitation affects commercial development. Currently, the Municipality is highly dependent on the Town water system for pressure and volume of water. Having a water tower providing increased pressure can be considered an investment in economic development.

Municipal staff investigated opportunities to incorporate renewable, energy efficiency and other sustainable measures into this project. Engineering advice on this effort was provided by Hatch Engineering. Municipal staff also followed up with officials from the Federation of Canadian Municipalities and QUEST. Unfortunately, no practical initiatives have come forward.

## MUNICIPALITY OF THE COUNTY OF

Future phases to capture maximum benefit of the added storage would include looping of various lines along Trunk 7 (Nova Landing, Keating Court, Tamara Drive and Elliot Lane), replacement of aging lines along Trunk 7 and Post Road, and other opportunities to connect and enhance Crocket Country. These future phases have not yet been costed and would make up a portion of the Municipality's ongoing asset management investments.

#### **BUDGET CONSIDERATIONS**

A phased approach to this project is being recommended. The first phase is the most significant, and includes the construction of the water tower, a transmission line to Trunk 7 and a distribution line connection at the Post Road near the Depart of Fisheries Office. This initial phase is estimated to cost approximately \$2.7M. There are two options for funding:

#### 1) Prioritize the Post-Road Water Tower for Other Government Funding

The primary opportunity for other government funding is the Investing in Canada Infrastructure Program (ICIP). If successful, the Municipality could see up to 73% of the total project cost funded by the federal and provincial governments. The remaining project costs could be funded through a combination of reserve funding and utility rates.

Funding for the North Grant Waterline Extension and the Church Street Extension to Beech Hill Road Looping projects were funded through ICIP in 2019/20. There is no timeline available for another offering of the ICIP. As such, the Municipality would have to wait to tender the project until an application was approved. If this project were identified as a or the top priority, it would displace an opportunity for funding for other municipal projects.

#### 2) Fund the Post-Road Water Tower Internally

The Municipality can use a combination of Gas Tax Reserve, Water Utility Reserve, General Capital Reserve and Municipal Finance Corporation (MFC) debt to fund this project. The Municipality has been diligent to build reserve balances to provide the flexibility in making these kinds of significant investments. Allison will attend the meeting to provide an overview of various fund balances and discuss MFC borrowing. If funded internally, the Municipality can manage this project based on its own timelines and it would create an opportunity for another project to be identified for eventual ICIP funding.

#### NEXT STEPS

At the direction of Council, staff are prepared to move this project forward as follows:

- Incorporate this project in the 20/21 Capital Plan and determine funding model;
- Prepare design drawings; and
- Prepare a tender package.

#### **RE: POST ROAD WATER TANK ASSESSMENT**

The Municipality of the County of Antigonish wish to assess the benefit of a water storage tank in the Post Road area with respect to system pressures emergency storage and fire fighting capability. As part of the investigation is the assessment of interconnecting the Post Road area water system with the No. 7 Highway water system.

An earlier assessment (January 24<sup>th</sup>, 2019 Letter Report) which we carried out determined that the existing booster pumps located on the Post Road could fill a new storage tank which could be located on the highest ground in the area, behind the Walmart building. The booster pumps located on the No. 7 Highway could also be used to fill the tank either instead of the Post Road booster station or in conjunction with it. If it were to be used instead of the Post Road booster station, the fire flows from the Post Road Booster Station back to the Post Road meter would also see improved fire flows instead of the same low values as seen in the following table (nodes 3120, 3122 and 3124).

The previously mentioned letter report recommended that the Municipality have EXP enter into their water system model (Includes Town and County lines) the affect of the proposed tank, the connector line from the Post Road water system to the No. 7 Highway water system and a few waterline looping connections in the No. 7 system.

This was carried out by EXP and the results summarized in the attached table. The table includes the current system pressures, future pressures with new tank, existing fire flows, recommended fire flows, future fire flows, with the tank on line and future with additional line looping (No. 7 Highway area)

As can be seen in the Table, none of the existing areas in the Post Road zone have fire flows meeting the required fire flows (according to the Fire Underwriters Survey (FUS) publication "Water Supply for Public Water Protection"). With the new tank on line, many of the areas in the zone would have much increased fire flows with most areas meeting and exceeding recommended values.

As with the Post Road area, none of the Lochaber Road area have fire flows meeting the recommended values. When connected to the Post Road system by adding a 12" connector transmission line, many areas get fire flows meeting (or close to meeting) required fire flows. Parkhurst as well as out the #7 Highway to the Ultramar are exceptions with fire flows still very low. When some looping is carried out as per Figure No. 1 attached, only Heritage, Ponderosa and out the #7 Highway do not get recommended fire flows.

After you review the contents of this letter you can touch base with me to discuss the contents and see what you feel the "move forward" approach the Municipality wish to follow.
