RE: Request for Variance for Property PID 01234723, Mount Cameron, Antigonish County, NS.

Your recent request for a variance (please see attached map) on the reference property is being granted. Policy 5.14 of the Municipal Planning Strategy for the Antigonish Fringe Plan reads as follows:

In addition to the general powers granted in the Municipal Government Act, the Act also empowers the Municipal Development Officer to grant "variances" from the Land Use By-law. Specifically, the Municipal Development Officer may vary the percentage of land that may be built on, the sizes of yards, courts and other open spaces, lot frontage, and lot area. Should the Municipal Development Officer grant a minor variance, he/she must serve notice of this action in accordance with the Municipal Government Act. Anyone served with such notice may appeal to Council.

A variance will be granted to reduce the lot size requirements requirement from 5000 sq. ft. per dwelling unit to a minimum of 3500 sq. ft. per dwelling unit. This request for the variance is to allow the placement of duplex dwelling units on lots adjacent to existing units on similar size lots. All other requirements of the Land Use By-Law will be met. In accordance with the *Nova Scotia Municipal Government Act* we are required to notify all assessed property owners within thirty (30) metres of the subject site. The individuals notified have the right to appeal this decision within fourteen days of this notice in writing to the Municipality of the County of Antigonish at the following address:





I am writing this letter to appeal the process granted to Variance of Property PID 012347234 Mount Cameron, Antigonish, NS

I received the letter of variance and development on Thursday, August 6th, 2015 with the outline that was requested and granted to the developers of many duplexes that will be built on Highway 337(where I am located). I was unable to reach anyone until August 10 when Wanda Ryan called me on Monday from Port Hawkesbury. I then called her on Tuesday, August 11th in Antigonish and she was very helpful. That gives me of 7 days to post mark and appeal this process.

I am appealing the decision for the reduction in variance granted and several issues that I am gravely concerned about by these duplexes being built and driveways being directly off the Highway 337.

1) Property Value of our existing and future homes---There was a previous By Law that was for 4000 square ft required per dwelling and that changed to the existing size. I am unconcerned about what was in the past regarding what was required. I am concerned that 1500 square ft was reduced "per dwelling" from the existing 5000 square ft. for these duplexes. That is 3000 square feet per duplex and 21,000 square feet for all duplexes combined. This is an enormous amount of land that has been reduced. This is significant and leaves nothing to the imagination of how crowded and congested these new developments will be to one another. The optics will be terrible in my opinion and the beautiful landscape will be ruined or at least reduced. This will have a real affect on people's views and perceptions of this great neighbourhood and landscape. There was a reason for the "existing" By Law that requires 5000 square feet, and that variance should not be reduced to 3500 per dwelling because of what previously existed and now there can be more duplexes. This is to save money and just because the developers had placed driveways in these places over one year ago is not a good enough reason. The By Law should follow the development of the home, not the driveway. By Laws should be adhered to, and unless there are exceptional circumstances, then developers should abide by what we all have to abide by when dealing with developments. Ms Wanda Ryan was of great assistance to me and explained that because the driveways were already in these developments, that she was open to reducing to 3500 sq ft from the 5000 in the new By Law per dwelling. I am in disagreement with this decision, as this is not one duplex and one small developer. The existing 5000 sq ft per dwelling should be reinstated and this would reduce the footprint overall for the amount of the many duplexes planned. Instead of 7 there would be approximately 4. This is no reflection of Ms Ryan, but I again disagree with this change to variance, as any other homeowner would have to abide by the regulations and By Laws that exist at the time of construction, not the time of constructing a driveway over a year ago.

- 2) Consultation-There has been virtually no consultation with the people like my family who have lived here all of our lives. First it was a vote on whether even water and sewer should go down this road, and Mr. Allan Bond sent a letter out about 15 years ago and asked who on the road wanted the water and sewer. Two people of the entire Landing Road voted in favour and all the rest opposed. This was delayed for several years until County Council forced the water and sewer down this road using the Antigonish Abattoir as the reason to do so, stating that they would have to close the plant if water and sewer was not brought down to them. That was the beginning. Shortly after, a large developer bought an enormous tract of land and is now putting a subdivision across from where we live. We have come to terms with that, however we warned councilor's and others that some houses that were considered to be built on the Highway 337 would have flooding issues as we know what the landscape was before the excavation to remodel the subdivision. It was a flood zone. Flooding has occurred and one home has been bought back from the homeowners because of this, and others have moved and sold their homes. The "only" reason that I and my wife were notified is because the Municipality Government Act states that all homeowners within 30 metres of proposed developments. This lack of consultation and now the short period of time to appeal is just an indication of the respect shown to the people of Antigonish Landing.
- 3) Danger and Safety—The speed limit must be reduced and double lines must be in place visually as there has now become a very serious safety issue. My wife and I and neighbours have nearly been struck when turning left to go into our driveway(s) where these new developments are being done. This new development will place 14 more driveways that are right off this highway increasing this possibility of accidents. I have suggested many times that the houses if needed to be built near the road, could

easily have their main road to their properties the same as the first three houses on the right hand side that are on this highway past Bethany. Their road is off the highway and exists now from Mount Cameron. The houses that use this road do not impede the traffic in any manner on Highway 337. With the development of all of these driveways, I will predict that there will be accidents that are waiting to happen and I for one am not allowing this without at least my objection. The speed limit also needs to be reduced from 80 kms an hour to minimum 70 and optimum would be 50 kms per hour. The existing 80 kms is far too fast and we have been nearly killed by cars flying by us as we turn into our driveway, and I have witnessed the same for the new houses built in the last several years. It would be irresponsible to pass this concern off to the Department of Transportation without appealing to Council as well, as this is being because a variance was allowed created more SO Municipality(s). There is absolutely no need to have these driveways having to turn off this highway, when there already is an existing road in Mount Cameron Estates that the first three houses past Bethany already have access to, and this continuance use for these new developments would make things so much safer and would probably also reduce the flooding implications.

4) Duplexes instead of houses—although I am against development on this Highway with driveways that turn directly from the Highway, duplexes are seldom owned and kept up in my opinion compared to houses. This is my opinion, but I need to express it as I have seen many things in my 60 years. These are often rented by people as most people do not want to buy duplexes. There will be a negative impact on the land around as there will be no stability and security for homes around. It is not unknown that renters do not up-keep the properties the same as new home owners and the duplexes that exist now in the subdivision are not well kept *in my opinion*, so it is a safe bet that some of these will also be unkempt. This is not to condemn renters but owners have a vested interest. facts

I spoke with Councilor Donnie MacDonald who has done a superb job of contacting both Wanda and the RCMP about 3 of my concerns. The RCMP will do spot checks for speeding down our road. And the Department of Highways will be placing the double lines out near our rd so that hopefully the speeders will at least not pass. This will be helpful to us who have had close calls with people passing vehicles and speeding, however we need to have the kms per hr reduced, and driveway access revisited to these new developments as many more people will be coming and going from these domiciles. Wanda Ryan was also of great help, as she explained the reasons why the variance was granted, however I still want to be on record as opposed and this is my formal appeal.

 About 20-25% of participants are international, and represent every continent (except Antarctica).

# 2. Economic Impact

- <u>Fact</u>: This conference will attract many first-time national and international visitors to this region, many with discretionary income to spend.
- Objective: Try to get as many people to attend the Antigonish conference, and have a large proportion of them stay beyond the conference dates. This would maximize the economic impact.

# Direct Economic Benefits

- With minimal effort, we can expect to attract about 800 participants to the conference.
- $\rightarrow$  3 nights food & lodging for 800 = apx. \$400,000
- If marketed as an "exotic" location with many extra-curricular activities, we could get more participants to come and to stay longer.

# 3. What Can the County Do?

- If beautification/road projects are planned, try to get them done before June 1, 2017, or postpone them until after June 6, 2017.

Dear Mr. Hines:

By way of this letter, I wish to make a case for the upgrade and completion of paving of the Antigonish - Guysborough Road. While I realize that this proposal has been raised a number of times in the past, I firmly believe that the timing is right to move this project forward to the benefit of the village of Guysborough and, indeed, the Municipality of the District of Guysborough as a whole. The ultimate objective of this proposal would be to make the Village of Guysborough a destination point for Nova Scotians and visitors to our province alike.

At a time when many areas of our province are assessing their current and future economic stability, Guysborough has so many assets to build upon to ensure that they don't have to wander down the same path. While I recognize that you, as MLA for this area and a former Warden for the Municipality of the District of Guysborough, are keenly aware of these assets, I would like to outline many of them for the benefit of this request.

The village has at least 4 major dining venues. The Days Gone By bakery and dining room is well supported by local residents and visitors from the Antigonish and Strait areas. Big G's, with it's offerings of Greek and Italian foods is somewhat unique to a small rural community. The Rare Bird Pub has much to offer as a gathering place for, not only food and beverage but, entertainment and relaxation. For the many people who enjoy fine dining, the DeBarres Manor Dining Room provides first class cuisine for the discerning palate.

In the realm of recreation and entertainment, the community offers a nine hole golf course with a spectacular view of Guysborough Harbour; a managed marina that is capable of growing to meet demand; a provincial park that offers camping, hiking and other recreation amenities; live theater and a first class performance center.

The village offers many services for local residents and visitors alike. Whether one requires gas, groceries, prescriptions or banking, people's needs can be met. From spirits to postal services, to small scale shopping, Guysborough is well prepared to provide. Support services, such as hospital, nursing home, schools and churches, only enhance what a strong community can offer.

In addition, a major spin-off to being a destination point could be the promotion of Guysborough as a retirement area. The recent announcement on the development of a municipally owned sub-division supports this longterm goal. Attracting retirees to anywhere along this beautiful and scenic coast makes good and economic sense. The line from a movie, "build it and they will come", could, very well, apply to Guysborough.

I contend that the foregoing, when put together, is quite impressive. Guysborough has strengths.

It can be shown that success, whether it be personal, in business or in government, is best achieved through the application of two main factors, building on strengths and seizing opportunities. Guysborough has the strengths to build on. The opportunity may very well be found in the twinning of the Trans Canada Highway at Antigonish. There is proported to be a major exit being developed at Lower South River, right in line with Route 316, which will be only a short distance to the Antigonish-Guysborough Road. This can be, with careful planning and signage, the first opportunity to access a large and significant portion of Guysborough County. The benefits that can be achieved are numerous, with shorter driving times to the communities of Boylston and Guysborough, improved flow of traffic between the two counties, increased economic growth and a heightened development of cultural and recreational ties.

This may also be a great opportunity for you, as MLA for Guysborough and area, to have a positive impact on the economy of the Municipality of the District of Guysborough.

While I am passionate about this request, I have not conducted any polls or petitions. This has already been done in the past and is a matter of record. However, it is my intent to share this proposal with the stakeholders that would be impacted by such a project, including the Council for the Municipality of the District of Guysborough, and encourage them to comment, regardless of their position.

It is my sincere hope that you will initiate an urgent request to you government to proceed with the completion and upgrade of the Antigonish - Guysborough Road.

To all members of the Municipality of the County of Antigonish

I respectively write to you as a resident of the County of Antigonish and a retired Deputy Fire Chief for the City of Belleville. I have a serious concern that someone will either be killed or seriously injured at the lower entrance to Mount Cameron Circle on Highway 337 due to the excess speed that vehicles presently travel. I request that Council forward a request to the Nova Scotia DOT to have the speed limit reduced to 50k and posted between the two entrances to Mount Cameron Circle.

I personally have seen many close calls at this entrance and in my opinion they were all a result of excess speed and its only a matter of time until an accident occurs. One such incident happened when a vehicle pulled out to pass a stopped garbage truck just as a person was exiting the lower Mount Cameron Circle entrance and it was a very close to being a head on collision. There are numerous walkers who use the edge of the road to complete the loop back onto Mount Cameron Circle for their daily walks and I believe they are also in danger due to the excess speed as presently posted. These dangers will only be magnified when old man winter arrives and we have reduced visibility.

I thank you for your consideration in this matter and I look forward to your reply.
