1. **Call to Order – Chairman, Warden Owen McCarron**

4. **Business Arising from the Minutes**

There was no business arising from the minutes.

5. **New Business**

a. **Active Transportation Corridor Plan Presentation**

The consultants from WSP presented the Active Transportation Study Report. Following the presentation, Councillors from the Town and County were given the opportunity to ask questions of the consultants:

- How much of the Blue Route is finished?
 - The map on page two of the report outlines the progress of the Blue Route. Trunk 4 and the connection through Town would be part of the Blue Route.
- How were the surveys completed, and what was the response rate?
 - Page five of the report provides information about the public participation in the project, including the survey and in-person engagement sessions. A total of 265 surveys were completed.
- What is the involvement of the Department of Transportation and Infrastructure Renewal?
 - They sit as a stakeholder on the steering committee. They do not have money to contribute to specific active transportation facilities but are including accommodation of those facilities in new or improved road surfaces. Provincial funding will need to come through application.
- Questions of clarification were asked regarding the proposed project phasing, funding, and facility type.
- Are the routes designed to be functional year-round?
 - Yes - most are asphalt surfaces. Maintenance is up to each municipal unit.

- What is the economic benefit of bringing the Blue Route to the area?
 - Users of the Blue Route will use the facilities and patronize the businesses in the area. Tourism should increase. Consultants don't have specific economic impact data. Bicycle Nova Scotia can be brought in to do a presentation on the Blue Route.
- What types of surfaces are tracking through Masstown and Pictou?
 - Unknown at this time but will follow-up with DTIR to find out.
- Why the focus on Trunk 4?
 - Focusing on Trunk 4 because it is an existing piece of infrastructure that is now overbuilt with the highway by-pass and provides an opportunity for a start. Trunk 4 can act as the spine to the active transportation system, and further expansion can connect into that spine as opportunities grow.

Councillors expressed their appreciation and thanks to the Town and County Recreation Departments and the consultants for the work that has been completed.


