### **Additions to the Agenda**

#### Crosswalk on 337 at Mount Cameron

Councillor MacDonald requested Council's endorsement of a letter to representatives from DTIR and the local MLA petitioning for a crosswalk at Mt. Cameron on Highway 337. He noted the volume of both pedestrian and vehicular traffic in that location was a concern and wishes to request a crosswalk with a flashing beacon.

A question was asked as to whether staff has been in contact with local Department of Transportation representatives. Mr. Horne reviewed the different requests made over the past several years.

*That the Committee of the Whole recommend that Municipal Council approves that a letter be sent to the Minister of Public Works, the local MLA, and representatives from the local NS Public Works office requesting consideration of a crosswalk on Highway 337 at Mt. Cameron Circle.*

#### Snow Removal for Seniors

Councillor Mattie has been contacted by several constituents asking of whether there are any programs available to help seniors with snow removal. Warden McCarron thought that there might be a provincial program. Councillor Mattie noted that one constituent did contact 211 to enquire about provincial programs that might be available. Councillor McNamara noted that he has also received similar enquiries.

Havre Boucher Streetlights

Councillor McNamara noted that requests made early last summer for streetlight installations have not been fulfilled by Nova Scotia Power to date and asked whether there was anything that could expediate those installations. The Warden suggested that a list of outstanding streetlights be compiled to facilitate the discussion with Nova Scotia Power. Councillor McNamara noted that there is a streetlight at Exit 38 on Highway 104 as well.
