Continuing Business

Tender Awards

St. Joseph's Water System Expansion

Mr. Horne reviewed the process for the tender for the St. Joseph's Water System Expansion. Four bids were received, and Mr. Horne reviewed the details on the lowest bid received. Mr. Horne noted that the tender does not include the water tank, which will come forward in a separate tender. A tender award is not being sought at this time because the project has been flagged Federally for aboriginal consultation. Discussion followed regarding the consultation requirement and project timelines.

Vincent's Way Sidewalk, Curb & Gutter

Three bids were received, with the lowest bid being from B.D. Clifton Contracting Ltd. For the amount of \$825,037 + HST, with work expected to start on May 1st.

The Committee recommends that Municipal Council awards the tender for Vincent's Way Sidewalk, Curb and Gutter to BD Clifton Contracting Ltd. In the amount of \$825,037 + HST.

ICIP Project Updates

Net-Zero Community Buildings

Mr. Horne provided an update on the tenders that are in process for lighting and solar installations that are a part of the project.

Review and Feedback of the 2023/24 Capital Plan

Mr. Horne reviewed any updates made to the 2023/24 Capital Plan since the plan was reviewed in detail at the last meeting. Mr. Horne noted that the plan should be ready for approval at the next committee meeting.

New Business

Multi-Use Path Connecting Bethany Gardens to St. Martha's Hospital

Ms. Melanson provided the committee with a review of the Community Active Transportation Network map, giving updates on the work that has been done to date on establishing trails and the planned connections that are still in the works. An update on funding applications that have been applied for and the status of those applications, and upcoming funding programs that staff is preparing applications for were reviewed as well. Specifically for Bethany Hospital Connector Trail - In looking at applying for the CCTH Trails Expansion Fund and Connect 2 Fund, the cost sharing breakdown would leave the Municipality needing to look at a contribution of 25% of the project cost, committing to \$73,696.

Moved and Seconded

The Committee recommends that Municipal Council commits \$73,696 in the 2023/24 fiscal year to support funding application for a Multi-Use Path connecting the Bethany Gardens to St. Martha's Hospital as part of the Community Active Transportation Network.
