#### Review of the 2023/24 Capital Plan

Mr. Horne reviewed the updated 2023/24 Capital Plan. Attention was drawn to the West River Waterline Relocation, where further discussion regarding the changes to the scope of work based on design information supplied by the Province took place. A question was asked from the Committee about whether further pricing information was available for the Pomquet E-1 Pump Replacements. Mr. Horne provided an update regarding the water system expansion projects that have been flagged by the Federal Government for First Nations Consultation.

Mr. Horne noted that the Lanark Waterline Expansion tender was ready to be advertised, and consensus was given by the Committee to carry forward with that process.

#### ICIP Project Updates

# Net-Zero Community Buildings

Ms. Feltmate provided members of the Committee with a further update to the status of the project. Three tenders have been released for the work to be done, and two have closed and are ready to be awarded. Ms. Feltmate reviewed the scope for the two tenders and provided a summary of the bids received for each tender.
