OF MUNICIPAL AFFAIRS AND HOUSING

Please see the attached letter from the Hon. John Lohr, Minister of Municipal Affairs and Housing. Minister Lohr has asked that Municipal and Town Councils confirm their request to consolidate into one municipal unit by resolution. An emergency meeting has been called for this purpose for Tuesday, January 30th, 2024, at 6pm. This meeting will be held virtually.

The letter from Minister Lohr states that, *“If the position of the Town and County remains that you are requesting a consolidation of your units, the Province is prepared to introduce special legislation during the next session of the legislature, commencing on February 27.”*

If Councils confirm their request, a new boundary review process will be undertaken as part of the consolidation process. Therefore, we are suspending activities associated with the boundary review until Council makes its decision. This will avoid confusion between the two processes and additional unnecessary costs.

Dear Mayor Boucher and Warden McCarron:

I am writing to you further to the October 20, 2022, resolution of both Town and County Councils that stated:

“Municipal Council requests the Provincial Government to consolidate the Municipality of the County of Antigonish and the Town of Antigonish into one municipal unit through special legislation.”

With more than a year having passed since this Resolution and now having the clarity of the Nova Scotia Supreme Court decision affirming the right of municipal units to make a request of the Provincial Government to introduce special legislation amalgamating your communities, I felt it prudent to follow up.

The Province is seeking confirmation from the Town of Antigonish and the County of Antigonish that your position remains that you wish to consolidate your municipal units. Given the decision and clarity from the Court, the considerable discourse and public engagement on this subject, and the time that has passed since the initial Resolution, we would ask you to conduct an updated vote of Council and provide us with an updated request.

I would ask that you provide the Department with the results no later than February 23, 2024.

I understand some councillors may have concerns about potential conflicts in participating in a vote of this nature. If a councillor is concerned about a conflict and requires an opinion, the Department is able to provide one to ensure comfort and assurance in advance of participating.


