The meeting of the Asset Management Committee was called to order by Deputy Warden Bill MacFarlane at 5:29pm.

Business Arising from the Minutes

There was no business arising from the minutes.

Continuing Business

ICIP Project Updates

Net-Zero Community Buildings

Mr. Horne noted that the update regarding the project was included in the agenda package, with no significant updates since that memo was prepared.

St. Joseph's Water System Expansion, Lanark Waterline Extension

Mr. Horne noted that the delivery of the water tank is expected in the next few months.

Active Transportation Corridor

Mr. Horne noted that the design for the Church Street roundabout is in the final stages and is expected to go to tender in the next few weeks.

Review of Pine Ridge Stormwater Report

Kyle Cleary from Strait Engineering provided members of the Committee with an update regarding an engineering report prepared, analysing storm water in the Pine Ridge Subdivision. Mr. Cleary reviewed the different site visits that were undertaken when reviewing the report and spoke to the rainfall data that was included in their report. Councillors were provided with an opportunity to ask questions of Mr. Cleary about his report. Discussion followed regarding culvert sizing, ditching options, and water in basements in the community. The example of the extreme weather events in February was discussed.

A cost estimate for upgrades to the stormwater infrastructure in the community was prepared and included in the report. Direction was provided from the Committee to look at the water flow during another large rain event, and to look at options for larger

culverts in the area of concern. Councillor Dunbar then spoke about the challenges of significant snowfalls and snow removal in the Pine Ridge Subdivision.

Review of Draft 2024/25 Capital Plan

Mr. Horne provided an update on changes to the last draft of the capital plan that was reviewed in detail at the last Asset Management meeting, as outlined in the memo provided to the committee. Staff is looking for consent from the Committee to tender three projects based on funding being secured:

- AAHS Waterline Extension
- Hwy 337 Sewer Extension
- Bethany / St. Martha's AT Connector

Consensus of the committee was provided to issue those tenders.

Tender Award – Appleseed Drive Repaving

Deputy Warden MacFarlane declared a conflict of interest and removed himself from the discussion, with Warden McCarron stepping in to chair for the duration of this item of business. Mr. Horne reviewed the bid summary provided by Strait Engineering, for the section of Appleseed Drive from Market Street to D. MacIsaac Road. Three bids were received; the recommended bid is the lowest bid.

Moved and Seconded

The Asset Management Committee recommends that Municipal Council award the tender for the paving of Appleseed Drive to Nova Construction Co Ltd at the bid price of \$385,819.00 +HST.

Streetlight in Bayfield

Deputy Warden MacFarlane resumed the Chair. Councillor Dunbar spoke to a streetlight installation request that was approved by Council back in 2022, which has since been quoted for additional costs for installation. Councillor Dunbar asked that the municipality ask the NS Department of Public Works for permission to install the new pole and anchors as required for this streetlight.

The Asset Management Committee recommends that Municipal Council write a letter to NSDPW to ask to install the new pole and anchors as required for the streetlight.

New Business

Closure of Cape Jack Road

Councillor McNamara expressed a concern with water over the roadway on Cape Jack Road, noting a number of instances where the road was flooded. Videos of the flooding were shared. A petition has been prepared by residents in the roadway.

Moved and Seconded

The Asset Management Committee recommends that Municipal Council send a letter to the Minister of DTIR regarding concerns with the flooding of Cape Jack Road.
